Since the Unicef and Alternative Sociale Association study on Children Left Behind in Romania in 2008 that let the phenomenon be known, over the years the European Parliament and the EU Commission committed to an active understanding of the children left behind issue.

In 2012, the European Commission published a wide European study "Social impact on Emigration and rural –urban Migration in Central and eastern Europe" looking also at the impact of migration on vulnerable groups like children.

The European Conference Left Behind of March 2011 promoted by Fondazione L'Albero della Vita, in collaboration with Fondazione Patrizio Paoletti, Eurochild and Childrenleftbehind.eu – the thematic network that was official presented on that occasion - made the issue manifest as a European phenomenon involving hundreds of thousands of children in the EU.

Present round table discussion with experts and policy makers is a necessary further step to make progress in the active promotion of children's rights and well-being in transnational families, thereby stimulating parliamentary debates and furthering employment and social policies.
