Romanian's Migration Stages

Before 1989 – «the runnaways»



- 1989 2007 «over 2.5 million Romanian families had at least one member working abroad» (12% of adults aged 18-59) – Open Society Foundation (2006)
- 2007 present «350.000 children have one or both parents working abroad» (UNCEF/Alternative Sociale, 2008), over 60% of the Romanians working in Italy would look for a job in another EU country rather than return to Romania (CARITAS, 2010)

- Motivation social and economic
- Relative poverty and achieving life goals (Alternative Sociale, 2005)
- Sacrifice vs. priorities

Romanian's Migration

Parents' migration – positive effects

- Better financial condition
- Higher life standards (better living conditions, health, education for the children left at home)
- Debts paid
- Less conflicts
- Positive life experience for all family members (parents and children get in touch with different cultures)
- A more positive outlook on life

Romanian's Migration

Parents' migration – negative effects

- Mental health issues
- Vulnerability to abuse/neglect
- Deterioration of family relations

(between parents, between parents and children)

- Economic issues (34 % of the migrants declare that they did not achieve the material goals which determined their migration)
- Negative models related to how families should function (responsability to one another/distribution of roles, strength of relations etc.)

- «Home Alone» (Alternative Sociale)
- «Children of Migrants/ Children left Behind» (European Parliament resolution of 12 March 2009)
- «Euro-orphans» (Poland, Nederlands, Baltic countries)
- «Children with parents working abroad»
- «Children (temporarely) abandoned»

Children left behind

Independent statistics (UNICEF, Alternative Sociale)


- An estimated 350.000 children with one or both parents gone to work abroad
- An estimated 126.000 de copii have both parents working abroad
- Half of the children with both parents gone to work abroad are under 10 years old
- 4% of the children with both parents gone to work abroad are under 1 year (over 5000 children)
- 16% of the children have spent more then 1 year apart from both parents gone to work abroad
- 3% of the children have spent more then 4 years away from both their parents
- More then half of the "home alone" children come from rural areas



- 2006-2008 Awareness raising and information campaigns on the risks and vulnerabilities of children and families associated with the migration of parents;
- 2007-2010 Trainings for professionals social workers, psychologists, teachers, police workers etc.;
- 2007 An awarded Methodology for the Social, Psychological and Legal Assistance of Home Alone Children;

- 2007 **Lobby** for the optimization of the relevant legislation and of practices in the activity of public institutions for the prevention of separation (of parents and children) and for the assistance of home alone children;
- 2007 <u>www.singuracasa.ro</u> website containing information (research reports, methodologies, legislation, advice, a discussions forum) for children, parents, caregivers and professionals.
- 2009 **Strategic partnerships and collaborations** for bringing the issue to the attention of Romanian parents abroad, to the attention of European institutions and for assessing the European dimension of the phenomenon.
